For the information of the Bureau, referenced Tampa airtel set out that San Juan should resolve the matter that a confidential source at San Juan reported that SANTO TRAFFICANTE and JAMES RIDDLE HOFFA owned the Hotel Ponce de Leon in Santurci, Puerto Rico; and referenced San Juan airtel to Tampa (IO) noted that EUGENIO LEAL, according to several San Juan PCIs, had been formerly operator of an exclusive restaurant in Havana, Cuba and who was identified as a big time gambler and who had gambling connections with SANTO TRAFFICANTE at Havana, Cuba, had been in the Condado Beach Hotel, San Juan on 10/4/63, departing 10/18/63, furnishing address of 7871 S. W. 16th Street, Miami, Florida, and again registered 10/31/63 - 11/30/63, same hotel, giving address of 3590 S. W. 40th St., Miami, Fla. LEAL was also reported as being in business with EUGENIO GURRA, described as a well-known sports promoter in the San Juan area.

San Juan requested Miami and Tampa review files and advise if there were any present connections, legal or illegal, between LEAL and SANTO TRAFFICANTE.

In view of the above, a review of the Tampa file was made and the following is set forth, noting Miami is being considered Office of Origin, and it appears San Juan should conduct investigation to determine LEAL's activities in San Juan, establishing whether he is operating legally or illegally for himself or fronting for someone else.

TP 8-C, who has furnished reliable information in the past and who is presently furnishing his services to the Las Vegas Division, advised on October 19, 1961 that through sources familiar with Cuban activities in Miami, OTTO SIRGO, a Cuban actor described as a "drug addict" and who was involved in narcotics traffic in Cuba, as well as RENE CABELL, a Cuban singer, were in the Miami area at such time and that their names were linked with EUGENIO LEAL, who was described as formerly operating the Montmarte Night Club and Casino in Havana, Cuba. Source said that if these two individuals were in Miami, LEAL in all .

MM 492-S advised at Miami, Florida on 1/25/62 that SANTO TRAFFICANTE, JR. was in contact with EUGENIO LEAL, a recent arrival from Cuba. LEAL, according to source was a close friend and associate of SANTO TRAFFICANTE in Cuba and also the source was close to LEAL.

HERBERT WALL, Miami attorney (protect identity) on recontact May 16, 1963 in Miami, Fla., confidentially advised the identity of his clients who had leased the "Orange Sun", a cruise ship then running from Miami to Bimini for gambling purposes, were AVARISTO GARCIA VIDAL and EUGENIO LEAL.
