SF-2550-C-TE advised SA ROY L. ERICKSON this date that he was visiting with ALEX CAMARATA, a neighbor of his, last night. (It is noted the informant and CAMARATA are both members of the above organization and were involved with PETE MISURACA in an attempted extortion of HAROLD SMITH, part owner of Harold's Club, Reno, Nevada, based on an alleged debt owed to PETE MISURACA on the part of HAROLD SMITH. Several trips were taken to Reno by ALEX CAMARATA, PETE MISURACA and the informant in this connection. Lately, there has been a dispute between the three since PETE MISURACA is desirous of continuing efforts, even though the "organization" has ordered it be dropped for the time being.)

During the discussion last night, CAMARATA and the informant were talking about past history of PETE MISURACA and the informant mentioned that he recalled PETE MISURACA once stating that he had been to Jackson Hole, Wyoming, with HAROLD SMITH. ALEX CAMARATA became very upset over this, stating that PETE should not have mentioned this. CAMARATA stated that the "organization" had checked up on PETE MISURACA and his activities at Jackson Hole, Wyoming, through a person he identified as LOUIE BOSCHETTO (phn.). He identified this individual as a "friend of ours" which, in
