Re Philadelphia teletype 4-22-64 and Philadelphia airtel 3-23-64 captioned, "IGNAZIO DENARO, aka, AR."

According to re Philadelphia airtel, PH 672-C-TE, reported that PH 599-C-TE, Philip Testa and Nicholas Scarfo were together in Philadelphia Detention House on 3-16-64 and discussed Denaro. Further, that PH 599-C-TE told PH 672-C-TE that Denaro would be "hit."

In an effort to corroborate information furnished by PH 672-C-TE concerning Testa's proposed "hit" of Denaro you are requested to contact PH 599-C-TE as soon as practicable for information he may be able to furnish regarding Denaro's current strength within the Philadelphia family and whether he would be able to "stand up" under the impending ITAR prosecution. With this approach PH 599-C-TE might volunteer that a "hit" is out on Denaro or is being considered.

If PH 599-C-TE confirms the information furnished by PH 672-C-TE, you are directed to then furnish your views as to whether the Assistant United States Attorney handling the ITAR prosecution involving Angelo Bruno, et al., should contact Denaro's attorney to inform him that a "hit" is out on Denaro and that FBI Agents would be willing to further discuss the matter with Denaro.

NOTE: Retel advised that PH 672-C-TE, a key Philadelphia top echelon informant, has reported that Nicholas Piccolo, a Philadelphia family caporegime; Piccolo's nephew, Nicholas Scarfo; and Philip Testa (latter two in Philadelphia Detention Center) are afraid Ignazio Denaro (underboss to Angelo Bruno of Philadelphia family) will talk if jailed as a result of the FBI ITAR case in which Denaro was indicted. According to PH 672-C-TE Testa has indicated to this group and to PH 599-C-TE that Denaro must be "hit."
