It is pointed out that the informant could not be questioned closely, as to do so might reveal the Bureau's knowledge of any such plan and, further, the informant claimed to his knowledge the individual who is identical with the original informant in this matter has not been an acceptable member of the organization due to the type of criminal activity in which he is frequently involved. For this reason, any specific questioning might make that informant more susceptible to suspicion. In an effort to lead to the matter of current interest, a discussion was had with the informant concerning the association of FRANK NICOLETTI and ANGELO BRUNO since PHILIP TESTA has been confined at the Philadelphia Detention Center. The informant said in his opinion, any association between NICOLETTI and BRUNO was probably due only to NICOLETTI trying to develop a closeness to BRUNO, and not due to BRUNO having any more respect for NICOLETTI.
