ANGELO BRUNO, AKA., AR DAILY SUMMARY.

SOURCE ADVISED THIS DATE THAT YESTERDAY FRANK SINDONE SPOKE PRIVATELY WITH BRUNO. SINDONE IS CLOSE ASSOCIATE OF PHILA. FAMILY LA COSA NOSTRA MEMBERS IN VARIED GAMBLING ACTIVITIES. SINDONE TOLD CI THAT THREE OF SINDONE'S NUMBERS WRITERS HAD BEEN ARRESTED AND THAT BRUNO HAD ARRANGED FOR AL SCHWARTZ, PHILA. BAIL BONDSMAN, TO OBTAIN FAVORABLE DISPOSITION FOR THREE IN COURT. SCHWARTZ IS FREQUENTLY USED BY BRUNO TO QUOTE FIX END QUOTE CASES IN LOCAL PHILA. COURTS.

SOURCE ADVISED BRUNO STATED THAT ATTORNEY JAKE KOSSMAN IS HAPPY OVER RECENT SUPREME COURT DECISION ANNOUNCED FIVE EIGHTEEN SIXTYFOUR INVOLVING THE REVERSAL OF A NARCOTICS CONVICTION. KOSSMAN REPORTEDLY TOLD BRUNO THIS DECISION WILL HELP FRANK PALERMO IN EFFORTS TO REVERSE HIS CONVICTION IN BUCASE ENTITLED FRANK BLINKY PALERMO, AKA., ETAL, AR DASH EXTORTION DASH CONSPIRACY, OO: LOS ANGELES. KOSSMAN REPORTEDLY STATED RECENT DECISION PROHIBITS USE OF WIRE TAPPING INFORMATION IN ANY FASHION AND WOULD HAVE DIRECT
