A Philadelphia top echelon criminal informant, who is in close contact with Angelo Bruno and other racket figures in Philadelphia, has advised that a meeting of the Philadelphia "family" of La Cosa Nostra will be held at a motel in Camden County, New Jersey, on June 15, 1964. At this meeting "new rules" of the organization will be made known and possibly six new members will be "made" (admitted to membership). Informant, an admitted member of La Cosa Nostra and who has furnished valuable intelligence information concerning the leaders and members of the Philadelphia "family", has been invited to this meeting and plans to attend.

Informant has agreed to wear a recording device while attending this meeting in an effort to record the induction ceremony of La Cosa Nostra members and other events. He is fully cognizant of the potential dangers involved.

Philadelphia has requested Bureau authority to equip informant with a recorder to record this meeting. This recorder will be secreted on the informant's body in such a way as to afford all possible security. No open surveillances will be conducted in the vicinity of this meeting in order to insure informant's safety.

This is the first opportunity we have had to record the events which occur at a La Cosa Nostra new-member initiation ceremony. If successfully carried out the results should be highly significant.

It is recommended Philadelphia be authorized to equip their top echelon criminal informant with a miniature recorder as requested. If you agree, Philadelphia will be issued specific instructions along this line to insure that complete security is afforded this operation and all possible precautionary steps are taken to provide for informant's safety. This activity will be coordinated with the Laboratory. Appropriate airtel attached.
