SOURCE ADVISED SUBSEQUENT TO COURT SESSION JUNE TWELVE LAST, IN BRUNO
ITAR DASH EXTORTION DASH CONSPIRACY TRIAL, BRUNO MET WITH IGNATIUS
DENARO, SOTTOCAPO, PHILADELPHIA FAMILY, LA COSA NOSTRA, AND BRUNO'S
CO-DEFENDANT AT DENARIO'S INTERNAZIONALE CAFE, PHILADELPHIA.

TESTIMONY AT FRIDAY'S SESSION LINKED BRUNO WITH ABJUDICATION OF
PROBLEMS ARISING FROM DEFAULTED LOAN PAYMENTS. DENARO TOLD
BRUNO HE NEVER BROUGHT HIS, BRUNO'S, NAME INTO NEGOTIATIONS. DENARO
THEN SUMMONED CO-DEFENDANT COLIANNI AND COLIANNI ADMITTED TO BRUNO
THAT IT WAS HE WHO BROUGHT BRUNO'S NAME INTO NEGOTIATIONS.

DENARO TOLD SOURCE HE EXPECTS TO BE CONVICTED AND SENTENCED TO
ONE YEAR. BRUNO STATES HE ANTICIPATES QUOTE GETTING OFF WITH A
REPRIMAND UNQUOTE.
