On 5/29/63 Lieutenant JACK REVILL advised information had been developed from his highly confidential source that DOLAN had been in recent contact with RUSSELL DOUGLAS MATTHEWS (see above). MATTHEWS made a statement that "they" needed \$2,000 more to effect the release of associate and Dallas hoodlum GEORGE FUQUA (DL 92-61) on appeal from a Kansas State Penitentiary, where he is presently confined.

ALL THE ABOVE INFORMATION RECEIVED FROM LIEUTENANT REVILL WAS DONE SO ON A CONFIDENTIAL BASIS. THIS INFORMATION IS NOT TO BE DISSEMINATED OUTSIDE THE BUREAU AND MUST BE HANDLED MOST DISCREETLY IN ORDER TO PROTECT LIEUTENANT REVILL'S SOURCE.

On 5/27/63 DL 170C (DL 137-556) advised that WINFREY was presently staying at an apartment house in Dallas where he has telephone number TAYLOR 6-6412. According to CI, WINFREY is not working for his former boss JOHN ELI STONE and the above apartment is the one previously referred to by informant as that of an associate of WINFREY who had given the apartment to WINFREY because he, the associate, was afraid of arrest by the Dallas PD. The informant stated this associate is Dallas gambler PHIL STEIN (DL 165-37). A check of phone company records determined that the above phone number is listed to SAM DILLARD, Apartment 203, 5908 Gaston. Informant also advised that a man named ELLSWORTH of Houston, Texas, has been winning heavily on horse race bets placed with WINFREY and ELLSWORTH is the man previously referred to by informant as a heavy bettor from Houston.

Worth gambler, and IZZY MILLER from Dallas, opened a small game across from Amon Carter Airport in a large house and sneaked this game for a few weekends.
