Re: WILLIAM RAY DAVIS, aka. et al ITAR - GAMBLING; CONSP. (DL 166-110)

On 7/16/63, while BuAgents were checking Dallas motels and hotels to ascertain if any suspected out-of-state bookmakers and gamblers were in the Dallas area to attend the PGA Tournament, it was ascertained that STANOVICH had checked into Room 315 at the Cabana Hotel on 7/13/63. Coverage of his activities was arranged for through a source within the hotel and the Dallas PD was advised of the above.

Re: JAMES TRY DOLAN, aka. AR (DL 92-292)

On 7/15/63, the Denver Office furnished the following:

DN 249-C reported on 7/3/63 that during the last week in June, 1963, he received a long distance telephone call from DOLAN who stated that he was calling from the State of New Jersey, but furnished no other information as to his whereabouts. DOLAN told the informant that he and some of his associates whom he did not identify, were having a "beef" with ROBERT PIERRE FETONTI, FBI #459907 and that as soon as they found FETONTI "it would be the end of him".

DOLAN attempted to secure from DN 249-C the current address of FETONTI, but the informant told DOLAN that he had not seen FETONTI for two years and knew nothing concerning his whereabouts. Informant stated that DOLAN furnished no more specific details to him, but he got the impression that DOLAN and his unidentified associates had the intention of doing bodily harm to FETONTI if they located him. He stated the call was prepaid and undoubtedly DOLAN used either a fictitious telephone credit card number or a telephone upper housing key to make the call since DOLAN considerably used these methods to make long distance calls without paying for them.

Informant stated that as of August, 1962, ROBERT PIERRE FETONTI was residing in Apt. 22-K, 104-60 Queens Blvd., Forest Hill, Long Island, New York, telephone number Browning 5-3411. He stated at the same time FETONTI's brother, HARRY FETONTI was residing at 725 Columbus Ave., Apt. 3A, New York City.

The above information was furnithed to Dat. L. D. STRINGFELLOW, Dallas PD, on 7/19/63.
