Lt. DYSON advised PD investigation has revealed "patients" seeking treatment at the location have also been sent to Dr. EARL HOLMAN, a Dallas osteopath with offices in the Snyder Plaza.

On 8/16/63, Judge JIM MC CARTHY, ll6th District Court, Dallas County, Texas, granted a temporary restraining order prohibiting the Avalon Bath Parlor from opening for operation until a hearing can be held on a permanent injunction to close the place as a business. On 7/9/63, the license was revoked at this location for a number of law violations in recent years. This license revocation was appealed by the owner and has been operating while on appeal until a hearing on 8/26/63, at which time a final decision will be made. A petition has asked that a permanent injunction be issued against the operation at this location, naming EVELYN LOUISE DE WITT and A. J. PATTERSON as defendants and operators of this firm.

DL-121-C has advised one JOE WILLIAMS is owner of the Waldo Beer Lounge, 2910 North Fitzhugh, Dallas. He formerly worked at the Holiday Inn Central as a bellboy and was fired. A barmaid employed at Waldo Beer Lounge, one NITA RILEY, was formerly employed by the City of Dallas in one of the corporation courts.

On 7/31/63, according to informant, CHARLES MC KELNERY, aka Scotty, who is employed as assistant bell captain at the Cabana Motel, Dallas, was at the Waldo Beer Tavern and was contacted by an unknown man who was driving a 1957 Ford or Chevrolet. This man reportedly had a pistol under the seat of the car. This unidentified man mentioned Oceanside, California and gave the impression of being wanted there. MC KELNERY, according to source, was formerly employed at the Statler-Hilton Hotel, Dallas, and reportedly was fired there because of his The informant further advised that one DOTTIE criminal record. is frequently seen at the Waldo Beer Tavern and she is living as common-law wife with one "LEO" who is a bellman at the Holiday Inn Central Motel. Informant stated LEO checks DOTTIE in at the Dallasite Motel next door to the Holiday Inn Central and later sends her prostitution dates from the Holiday Inn Central.
