He said be was certain he had not seen them at the Tropicana Night Club precently. SISCHOPP noted that PRAD's photograph, taken in 1957, buars some recomblance to MARTIN-FOX, the owner of the Tropicana Wight Club, and that it is possible that someone seeing him with FOX might have mistaken FOX for PERO. BISCHOFF stated that in the event may information should come to his attention concerning PERO or SCIALO HAVOR he would advise the Legat.
