Airtel to New Orleans
Re: Carlos Marcello

NOTE: Former WF 1633-C-TE was in recent personal contact with Carlos Marcello, a leading hoodlum and racketeer in Louisiana. Marcello related he had obtained a news photo showing him carrying his raincoat on the arm he allegedly used in an attempted assault on a Bureau Agent. WF 1633-C-TE later viewed this photo in possession of Marcello's attorney who also stated he had found an error in the impanelling of the Federal Grand Jury which indicted Marcello. New Orleans is being instructed to discreetly attempt to locate copies of news photos taken of Marcello at the time of the attempted assault. It is noted that Marcello was re-indicted on this charge by a new grand jury on 6/1/67 because of the possibility that the original grand jury which indicted him 10/7/66 was improperly impaneled. It is not clear which grand jury WF 1633-C-TE refers to.
