NY [5181]-S on 8/5/71, furnished a handbill advertising a public meeting of the US-China People's Friendship Association. This organization is located at 2 East Broadway, NYC. The meeting was to be held on 8/8/71, at PS 41, 116 W. 11th St., NYC. It was their first public meeting. VICTORIA GARVIN (Bufile 100-379895) was to be present.

NY [5181]-S and other informants attended this meeting.

The handbill stated that additional information could be had by calling CH 2-0021 or [WA 5-8862.] (S)

A review of the files of the NYO reveals that CH 2-0021 is the telephone number of SUSAN HEILIGMAN FRANK (Bufile 100-339235) and WA 5-8862 is the telephone number of NY 5147-S (Bufile 134-4535) (S)

NY [5147]-S has been, and is being contacted concerning this organization.

Other contacts with informants who could logically be knowledgeable about captioned organization are pending.

When preliminary inquiries concerning captioned organization are completed, a report will be submitted to the Bureau.
