Referenced Chicago airtel, which outlines a recent National Interim Committee (NIC) meeting at Dayton, Ohio indicates that NIC delegates spoke of an organization similar in name to USPCFA. "He (7262) noted that RU does not intend this organization to be an obvious, blatant RU front.

On 3/15/71 LEIBEL BERGMAN, co-founder of captioned organization, told Alchemy source, 6547 s, that he had read and liked the Ad Hoc Bulletin Bufile 100-42715 CGfile 10041353). BERGMAN said he had read that pamphlet "at SUE WARREN's house," (Aka SUE FRANK NYfile 100-42479; Bufile 100-339235). It is obvious that BERGMAN and SUE WARREN are friends.

On 8/20/63, NY 4112-S advised that SUE WARREN had been in contact with TANG, Ming-Chao who was then reported to be head of political intelligence in English speaking countries for the Chinese People's Republic. As is known to the Bureau, it is believed that TANG was also BERGMAN's chief contact when he was in China. Chicago believes public documents have recently speculated that TANG Ming-Chao has been mentioned as a possible leader of the UN delegation of the People's Republic of China.

From the above Chicago believes it is possible that WARREN and BERGMAN are working together and that the USCPFA is an RU front.
