On September 7, 1971, a confidential source abroad furnished the following information: (c)

According to the source, SUSAN MILDRED FRANK, nee HEILIGMAN, a citizen of the United States born on August 11, 1913, in the U.S.A. departed Orly Airport, Paris, France, on August 16, 1971, en route to Peking, China. The source further described FRANK as a journalist who resides at 110 Christopher Street in New York City. (c)

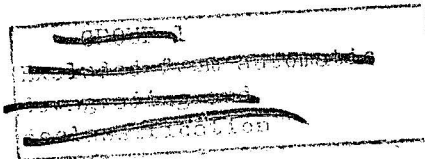
