Re New York letter 11/1/71 captioned "SUSAN HEILIGMAN FRANK."

Referenced letter indicates that New York has several sources who logically could be targeted against FRANK. Chicago believes they should be utilized to establish a rapport with the subject which must be done on a continuing personal basis. Chicago informants based a thousand miles from subject could not likely obtain information from her of more value to the Bureau than New York's sources notwithstanding the financial consideration involved. (S)(u)

If CG [5851]-S and CG [6328]-S have reason to travel to New York on [Alchemy] and other business, the prospect of their contacting subject will be considered at that time. CG [7262]-S full debriefing is imminent and any information regarding SUE FRANK will be promptly forwarded. (S)
