RICHARD FRANK has been known to have consorted with call girls in the past. It is presumed that the GRETA BERGMAN in LHM is similarly employed although she has no prostitution record under that name.

Spot observations conducted in the vicinity of subject's residence in January and February, 1973, proved negative.

It is noted that NY [11649] S, during this reporting period, furnished no information regarding any contacts of subjects with the PRCMUNAX Contact with NY 11992-S has been terminated. Bureau authority to contact NY [11769] PSI has been obtained and he will be asked to attempt to gain access to subjects. It is noted, however, that the Chinese wing of the USCPFA has left the organization and has formed its own Chinatown group. NY 5181 s has now returned to New York City from his overseas trip and remains alert to activities of the USCPFA and the FRANKS.

Referenced Bureau letter requested New York Office to review subjects' files in an effort to pinpoint specific instances of foreign espionage activity on their part. Investigation concerning the subjects encompasses nearly 30 volumes at the New York Office and dates from the early 1940s. A complete review of the above has been conducted without uncovering any specific instances of espionage activities on their part in the classical sense, other than inferences that may be drawn from information previously furnished in referenced New York letter of 9/14/72. It is noted that the Bureau determined this information to be insufficient in intelligence respects to warrant recontact with NY 4147-S in light of the "Keith Decision." Consequently,
