MI-5 states MARY JANE KEENEY departed the U.K. for an unknown destination 9/15/63, the day after FRANK arrived in the U.K. MI-5 has no recent information concerning KEENEY's activities, pointing out she last came to attention in July, 1961, when a secret and reliable source reported that ishe was, in touch with a Communist who was an official the British Council for Promotion of International Trade 🗸
