ReBucab 9/13/63 concerning RICHARD CYRIL FRANK and  
Buairtel 9/17/63 concerning MARY JANE KEENEY.

By letter dated 10/11/63, classified SECRET, British  
Security Service, MI-5, advised as follows: (S)

RICHARD CYRIL FRANK arrived in the United Kingdom  
9/14/63 and departed three weeks later, 10/5/63, for an un-  
disclosed destination. MI-5 states it regrets that to date  
it has not been able to obtain any information concerning  
FRANK's contacts and activities during his stay in the U.K. (S)

MI-5 points out it has not received any information  
to indicate that SUSAN FRANK has visited the U.K. within  
the past four weeks. (S)

MI-5 states MARY JANE KEENEY departed the U.K. for  
an unknown destination 9/15/63, the day after FRANK arrived  
in the U.K. MI-5 has no recent information concerning  
KEENEY's activities, pointing out she last came to attention  
in July, 1961, when a secret and reliable source reported  
that she was in touch with a Communist who was an official  
of the British Council for Promotion of International Trade (S)

MI-5 states it is making further inquiries re the  
FRANKs and KEENEY, results of which will be furnished in  
near future. (S)
