On November 8, 1963, Dr. ARISTIDE MANOPULO, Central Bureau, Criminal Division, Italian National Police, Rome, Italy, advised that Italian Police have still been unsuccessful in their attempts to locate NICOLO GENTILE. He advised that all police districts in Italy have been alerted and should any information be developed, he will notify this office by expeditious means.

Mr. MICHAEL G. PICINI, U. S. Narcotics Bureau representative, American Embassy, Rome, advised on November 18, 1963, that his office has also been unsuccessful in their efforts to locate GENTILE for interview.
