The source who identified MARCO LIMANDRI as a member is JOSEPH VALACHI, who on 10/10/63 advised he had no additional information concerning MARCO LIMANDRI but thought LIMANDRI might have been involved in the sale of stolen OPA stamps during World War II and subsequently went from New York to California

For information of the Bureau, FRANK BOMPENSIERO and JOSEPH JOHN LIMANDRI are presently being contacted in an attempt to develop them as informants under the Top Echelon Informant Program.

By letter dated 11/21/63 the Bureau advised that Los Angeles informant had advised that the Caporegima of the San Diego group is an individual by the name of ARNATO (phonetic).
