Re Miami airtel to Bureau, 9/5/63, NY airtel to Bureau, 9/13/63 and Miami airtel to Chicago, 9/14/63.

In referenced airtel dated 9/12/63, Miami requested NY to advise the mode of travel used by ALBERISIO to NY in October, 1962.

A review of the files of the NYO reflect that on 10/25/62, KENNETH OLDS, Reservation Manager, American Airlines, Chicago, Illinois, advised SA WILLIAM F. ROEMER that his records reflect that the Plan-It Travel Agency, West North Ave., Chicago, Illinois, made reservations on 10/10/62 for one A. M. DORFMAN, one I. WEINER, and one P. BOODY to travel from Chicago to NY on American Airlines Flight 26 on 10/15/62. Mr. OLDS advised that the reservation on behalf of DORFMAN was later cancelled and he was rescheduled on American Airlines Flight 104 from Chicago to NYC on 10/15/62. According to Mr. OLDS the flight manifest and checkout list reflect that the above individuals actually traveled on the

flight on which their reservations were made. There was no further identifying information concerning DORFMAN, WEINER or GOODY contained in the records of American Airlines.

On 11/1/62, Mr. THOMAS R. FITZMAURICE, Manager, Essex House, 160 Central Park South, NY, NY, advised SA PATRICK J. COLLINS, JR., that his records reflects that since 6/24/56 an IRVING WEINER, 3039 West Jerome, 420 North Orleans, and 412 North Orleans, all Chicago, Illinois, has been a frequent guest at this hotel. Mr. FITZMAURICE produced another registration card which the hotel maintains which is identical with the above described card which lists IRWIN WEINER, 7345 Damen, Chicago, Illinois, and business affiliation as American Bond Agency, 1137 South State St., Chicago, Illinois. According to Mr. FITZMAURICE, WEINER occupied Room 1902 with a P. GOODY from 10/15/62 to 10/18/62. The records at the hotel contains no informatin identifiable with ALDERISIO.

According to SA WILLIAM D. KANE, NY 3508-PC and SEYMOUR DANIEL SEGAL, victim in NY ITAR investigation on ALDERISIO, were unable to furnish any information re travel of ALDERISIO to Miami in 1962.
