 ADVISED DECEMBER 5 HE LAST EXAMINED SUBJECT ON MARCH 22 AND GAVE HIM PRESCRIPTION WHICH HE KNOWS HE FILLED WITH MAX CASTRO, MIAMI, AT UNION OPTICAL COMPANY. HE HAS NOT SEEN SUBJECT SINCE ABOVE INCIDENT AND A WEEK AGO SATURDAY HE CONTACTED JAMES C. LONGO COLUMBIA RESTAURANT WHO ADVISED HIM SUBJECT WAS IN MIAMI. NO ADDRESS ASCERTAINED. PHYSICAL SURVEILLANCE SUBJECT DAUGHTER SARAH AT RESIDENCE AFTERNOON DECEMBER 5, DAUGHTER MARY JOSEPHINE AT HENRY GRADY SCHOOL, TAMPA. PHYSICAL SURVEILLANCE FRANK TRAFFICANTE ESTABLISHED HE WAS IN AFTERNOON DECEMBER 4 AND 5 AT RESIDENCE AUGUSTINE PRIMO LAZZARA. SAM TRAFFICANTE, JAMES BRUNO, NICK SCAGLIONE OBSERVED AFTERNOON DECEMBER 5 AT PALM SERVICE STATION. NO SOURCES REPORT SUBJECT IN TAMPA. MIAMI DEVELOP CASTRO AS CONTINUING SOURCE RE SUBJECT'S GLASSES.
