Reurairtel 10-4-61, captioned as above, transmitting technical data for converting an Automatic Electric Company Monophone Model 80 for possible [SPMT] use in captioned case. (S)(U)

It is desired that you ascertain the effect the connecting of a 3000-ohm resistance across a subscriber's line will have on the ringing of the line. This should be determined for both TEL and LINE parties as well as for bridged ringing.

In addition, you should ascertain the position the "Line Compensating Rheostat" will be set for instant subscriber's line and how it will affect his telephone service if this component is permanently shorted out for the [SPMT] conversion. It is believed that this component may develop an open or become noisy if it remains in the circuit for microphone-telephone coverage. (S)(U)

Your reply should be directed to the attention of the Electronics Section, FBI Laboratory, at an early date.

ReBuairtel 9/26/61 and TPlet 10/3/61 captioned
"AUTOMATIC ELECTRIC TELEPHONES, TYPE 80," regarding the
forwarding of two type 80 Automatic Electric telephones
of the type used in the home of SANTO TRAFFICANTE, JR.,
and JOSEPH DIEZ, IGA - Numbers Lottery - Bolita (TP file 162-35).

It is requested that the type 80 telephones be
tested to determine whether they are compatible to the use of
the [RFMT] technique. This technique is being considered as a
possible means of covering the residence of SANTO TRAFFICANTE, JR.

It is requested that the colored telephone of the two
telephones forwarded be prepared by the Bureau for use with the
[SPMT] and returned to Tampa at the earliest possible date. The
resistance bringing up dial tone on the party line to which the
subscriber JOE DIEZ will be connected is 1930 ohms at the pole
terminal box. This plus 20% is 2316 ohms. This test was made
at the point where the [SPMT] connections will be made. An
estimated half mile of wire will extend from this point to
the subject's home. This technique is being considered for
the first sixty days authorized by the Bureau inasmuch as DIEZ
has moved into the new home and immediate access is not possible.
Arrangements have been made for the installation of the altered
telephone in this home.

After tests to determine the compatibility of the black telephone to the [RFMT] technique, this telephone should be retained by the Electronics Section until information can be furnished regarding the resistance of the "jumper" resistor. This telephone should then be converted for use with the [SPMT] technique. This will be requested by future communication for the home of SANTO TRAFFICANTE, JR. (S)(u)

An [SPMT] unit should be forwarded to the Tampa Office along with the colored type 80 telephone after it has been altered. (S)(u)

Due to lack of sufficient spare lines in the Tampa area, it is believed that use of the [SPMT] technique will require a plant [other than in the office of the FBI.] Surveys regarding locations and costs of plant sites are being made and will be the subject of a separate communication. (S)(u)
