By written report dated 2/14/62 CI MEX-46 (protect) who has furnished reliable information in the past, advised that several efforts had been made to locate NORBERTO FUENTES GARCIA at Calle San Juan de Letran 13, Room 1601, but was advised by building personnel that FUENTES had not been seen at his office in the last six months.

It is the opinion of MEX-46 (that FUENTES, if still(in Mexico, is violating Mexican immigration laws in view of his entry on 6/2/61, which would normally mean that his sixmonth permission to remain in Mexico would have expired about 11/1/61.

FLORENCIO VIVAS has been contacted on a regular basis and on 2/12/62 advised that he had been unable to obtain any further information as to the present whereabouts of FUENTES but, inasmuch as the Mexican Immigration Service has a pending case to locate FUENTES which is assigned to VIVAS, he will continue to make efforts to determine the whereabouts of FUENTES.
