The investigative period of this report pre-dates last investigative report due to desire to include results of investigation conducted in a Resident Agency, which results were not available at time of last report.

[REDACTED] a PCI of the New York Office, and an individual who has admitted intimate relations with TRAFFICANTE when TRAFFICANTE has been in New York, was not available for contact during July of 1968, but is to be contacted by the New York Office during August concerning any possible recontacts with TRAFFICANTE.

Information from records of the General Telephone Company of Florida was made available by Mr. HOWARD K. RUTHERFORD, Security Department, General Telephone Company of Florida.

Leads obtained from review of telephone calls made from TRAFFICANTE's St. Petersburg Beach residence are not being set forth in this report but are being handled in the investigation concerning TRAFFICANTE's son-in-law in the case captioned "AUGUST CECILIO PANIELLO," Tampa File 92-927, and if information obtained from these leads is deemed appropriate to TRAFFICANTE investigation, they will be reported by Tampa in subsequent Tampa reports.
