Investigation by our Pembroke Detachment in relation to correspondence from your FBI Albany office, reveals telephone number HE2-4136 is listed to William L. ELLIOTT, 39 Lorne Street, South, Renfrew, Ontario. William ELLIOTT died 26 JUNE 64 and is survived by his wife Edna, who resides at 39 Lorne Street.

2. Prior to interviewing Mrs. ELLIOTT, our investigator established that Edna ELLIOTT and Patricia Ann BOWEN were sisters, Mrs. ELLIOTT being 15 years senior. It was also established that GROSSI had visited at the ELLIOTT home in 1963 and that William and Edna ELLIOTT had a very poor opinion of GROSSI, however, tolerated him in consideration of Mrs. BOWEN.

3. Mrs. ELLIOTT was interviewed on January 18, however could offer no information whatever of value. She stated she had maintained close contact with her sister, both by letter and telephone. She openly stated her dislike for GROSSI and advised she would assist to locate him in any way possible.

4. Investigation is continuing.
