Assistance to the F.B.I.

Mr. Lloyd TRULL, 281 King St., Kingston, Ont., Vice-Principal, Kingston Collegiate and Vocational Institute was interviewed and he advised that he was aware of the facts surrounding Mrs. Patricia BOWEN'S husband. Mrs. BOWEN is presently on the teaching staff at Queen Elizabeth Collegiate and Vocational Institute, Kingston, Ont. being the head of the Classics Department. TRULL advised that Mrs. BOWEN was a close friend of Mr. Vernon READY, former Principal of Kingston Collegiate and Vocational Institute. In the summer of 1964 the READYS moved to London, Ont. and since this time Mrs. BOWEN has been in constant contact with Mr. TRULL. He also advised that he had been introduced to John GROSSI, who was using the name Jack BOWEN, during the summer of 1964. This took place at the home of Vernon READY where the BOWEN'S were visiting. Since the READYSShave moved from the Kingston area Patricia BOWEN has been a close friend of Mr. TRULLS and it would appear that she would confide in him should her husband contact her or have any of his friends do the same.

2. TRULL aslo advised that Mrs. BOWEN is residing at 36 Ellerbeck Ave., Kingston with her two year old son and her mother, who babysits while she works. She is highly regarded as a teacher by her superiors and there is no indication that she is involved with her husband in any way. She associates with a small group of personal friends, these being mostly fellow teachers. It was also mentioned by TRULL that Mrs. BOWEN would proceed with divorce action should she be able to get in contact with her husband.

3. William TATTON, 34 Ellerbeck Ave., Kingston, Ont., Classification Officer, Kingston Penitentiary, who is well known to all members of this detachment, was interviewed in regards to the possibility that he had noticed an American car in the vicinity of 36 Ellerbeck Ave. He advised that he could not recall any such vehicle in the last few months but stated that he would notify this office should he notice anything that might indicate that GROSSI was in the area. TATTON also faintly remembers GROSSI as an inmate at Kingston Penitentiary.

4. From the results of this investigation it would appear that Patricia BOWEN is no longer interested in or corresponds with her husband and would therefore not be involved in his activities or his friends. There is every indication that should GROSSI return to this area and contact his wife she would advise TRULL of same. THULL is comperating to the fullest extent with this Force.

5. No enquiries were made at Patricia BOWEN'S present place of employment as TRULL indicated that a very limited number of people know about her husband and it may cause embarassment for her should too many find out. It will be noted that TRULL has helped members of this detachment in the past and at all times has supplied good information. No further enquiries will be carried out at this point, however, should information in this regard come to light same will be reported.
