A Confidential Source abroad on January 22, 1965, advised that Mrs. JEANNIE STEWART, Apartment 305, 109 Erskine Avenue, advised she is the sister of PATRICIA EOWEN, and that she is well aware, that authorities are endeavoring to locate her brother-in-law, JACK LESLIE BOWEN, however, she has no information to offer now.

Mrs. STEWART stated she would cooperate if circumstances permit.

Mr. RUSSELL M. GERVAN, on January 22, 1965, advised that he owns and operates a real estate agency and is PATRICIA BOWEN's brother. Mr. GERVAN stated he had no information whatsoever concerning the subject's whereabouts, but would contact investigators in the event information concerning GROSSI is obtained.
