1. Will await Bureau decision regarding placing of subject's name on the Security Index.
2. Will, if subject's name is placed on the Security Index, appropriately disseminate to Secret Service.
3. Will, if subject's name is placed on the Security Index, verify subject's residence and employment every 30 days and develop sources in a position to furnish information indicating subject is exhibiting violent tendencies or planning to change his residence or employment, in accordance with instructions set forth in Bureau letter to Albany, dated 9/17/64, captioned, "DISAFFECTION OF UNITED STATES CITIZENS ABROAD."
