RE: UNSUBS; BOMBING OF CUBANA AIRLINES
DC-8 NEAR BARBADOS, WEST INDIES,
OCTOBER 6, 1976; CHILBOM

On 10/26/76 Mr. William Leurs, Deputy Assistant Secretary, Bureau of Inter-American Affairs, Department of State, was contacted by the writer and advised that Ricardo Morales Navarrete was not a source of this Bureau and specifically he was not being paid by this Bureau for his information. He was further advised that our Legat in Caracas, SA Joseph S. Leo, has contact with Mr. Navarrete in view of his position in DISIP and in view of the Legat's position in the Embassy. He was also told that our Legat would consider Mr. Navarrete a liaison contact with whom he has contact on almost a daily basis.] (S)(U)

Mr. Leurs stated that in connection with the proposal that the FBI send an Inspector to Caracas to interview the Legat Joseph Leo and to review pertinent files in the Legat's office, that the Ambassador in Venezuela requested that a decision on this proposal be delayed until Wednesday. The Ambassador further advised that things are still "very tight" in Venezuela but by Wednesday he thinks he will be able to give a more positive recommendation concerning the proposal. Mr. Leurs stated that he will advise the writer on Wednesday concerning the Ambassador's recommendation. The information concerning the sending of an Inspector to Caracas will be furnished to the Attorney General separately. (S)(U)

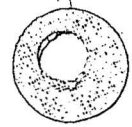
