PURPOSE:

Purpose of this memorandum is to advise of contacts by State Department officials with the writer concerning matters relating to captioned investigations.

DETAILS:

On 10/25/76 Mr. Culver Gleysteen, Coordinator of Cuban Affairs, Department of State, telephonically contacted the writer and advised that the State Department was considering having the U. S. Ambassador in Venezuela contact the President of Venezuela and advise him of the following:

The U. S. Government and, specifically, the FBI are not involved with the individuals who are considered suspects in captioned matters. He further stated that the Ambassador will tell the President of Venezuela that their people, the Venezuelan people, are much closer to the suspects than the U. S. Government's people. The Ambassador will acknowledge that in the past we may have had some association with these people but the U. S. Government does not have association with these people at the present time.

Mr. Gleysteen stated that he was furnished a copy of a Miami FBI teletype wherein it was set out that [redacted] who is presently a Section Chief within DISIP (Venezuela Intelligence) was a former source of the Miami FBI Office. Mr. Gleysteen requested to be advised if [redacted] was still a source of the FBI and specifically whether he was being paid by the FBI for information.
