IT IS DIFFICULT TO EXPLAIN SOME OF THE COMMENTS ATTRIBUTED TO [REDACTED] RECENTLY, PARTICULARLY HIS REPORTED EXPRESSIONS OF HOSTILITY TOWARD CIA AND FBI. LEGAT HAS HAD NO OPPORTUNITY TO BROACH THE MATTER WITH [REDACTED]. (S)u V-5
