A PCI, who is close to the activities of the MANNARINO gambling syndicate, on 8/4/60 advised that approximately one week ago <u>Pittsburgh National Top Hoodlum SAM MANNARINO destroyed several</u> <u>hundred multiple coin pin ball machines at the Ken Iron and Steel</u> Co. and had them buried on his property adjoining the family drive-in theater in nearby lower Burrell Township owned by his brother, Pittsburgh National Top Hoodlum GABRIEL MANNARINO. According to the informant, SAM MANNARINO ordered his machines destroyed to avoid the possibility of a raid on his warehouse by the PSP. As a matter of info, the AG of Pennsylvania recently declared multiple cointpin ball machines illegal. This ruling was followed by a series of raids by the PSP in which literally thousands of machines were confiscated. The State Supreme Court recently upheld the AG ruling and on 8/4/60 the PSP publicly burned hundreds of such machines near Pittsburgh. No new cases opened ordreferred to other agencies.
