On 1/24/63 SF 2550-C-TE furnished information he had received on the previous night while visiting at the home of ALEX CAMARATA and ROSE CAMARATA in Martinez, California.

The informant advised that a discussion developed involving activities in general concerning the organization they' belonged to, "Cossa Nostra." During the conversation ROSE CAMARATA mentioned an unsolved murder in Newark, New Jersey. She stated that a man named AUSTINO (phonetic) was killed by a member of the organization who she said, was a police officer having the name of LOMBARDINO. She stated this occurred in Newark when she was 11 years old and living with her parents in a grocery store on the corner of Bloomfield and Belmont. The informant advised that ROSE CAMARATA is now about 48 years old. She stated that the officer after killing AUSTINO hid his .45 caliber weapon in the store. There were two witnesses. The father of ROSE CAMARATA, JOHN MISURACA, was picked up for questioning but was released. There was a Jewish woman in the store at the time who was taken by members of the organization and threatened somehow should she divulge her knowledge of the murder. There was alsoa "Negro" boy and some contact was made with him to prevent him from divulging his knowledge of the murder.

It is requested that Newark endeavor to corroborate the above information.
