Legat London furnished the following information by cablegram 6/20/61 in response to your request for an additional check with our London sources in regard to the insurance policy allegedly held by Bruno on the casino at the Plaza Hotel in Havana, Cuba. (S)

"Recheck by sources with Lloyd's of London disclosed no other information available. Lloyd's does not require details as this is reinsurance request for American International Re-insurance Corporation. Lloyd's suggests only place this information available is the American International Reinsurance Corporation, New York. No further action here." (S)

You should insure the sources of the above information is given adequate protection in the event it is utilized in any investigative report.

NOTE: PH office requested additional check be made with Legat London in an effort to obtain additional information from Lloyd's of London regarding the above mentioned fire insurance policy which subj held on a gambling casino in Cuba. This casino was destroyed by fire and subj allegedly collected \$185,000 on this policy. This is a critical amount of money in connection with the IRS tax investigation on subj. (S)
