Re Pittsburgh airtel to WFO 4/29/58, in which a lead was set out to check long distance telephone calls.

CSWF-28 (protect identity) on 5/20/58 advised that ME 8-7520 is a non-published pay phone listed as U. S. Government, Senate Office Building. EX 3-8860, is a non-published pay phone listed to U. S. Government.

LD 7001 is an incoming trunk line from all parts of the United States to the U. S. Capitol switchboard. Ext. 1547, listed in reftel, has been changed to Ext. 5928, and Ext. 1632 has been changed to Ext. 5929 under the new Capitol phone system, effective January, 1958. Both new extensions, 5928 and 5929, as well as the old extensions, are listed to the office of Senator ALAN BIBLE (Dem.-Nevada).

WFO is making no further investigation to identify the party reached at the office of Senator BIBLE.

It is suggested Pittsburgh consider investigation through established sources in their territory in an attempt to ascertain whether subjects are attempting to effect contacts with legalized gambling outlets in Nevada. No investigation concerning the office of Senator BIBLE should be conducted unless approved by the Bureau.

Information concerning CO 5-7641 will be furnished the Pittsburgh Office when received from CSWF-28 (protect identity).
