No identification of this individual is in the witness list except an address "Binghamton, New York." It is probable he is identical to [REDACTED] bellhop at the Arlington Hotel, Binghamton, New York, since 1943.

[REDACTED] is currently a PCI of the Albany Division. His file was opened 10/15/59, and we have been in contact with him as a PCI, initial contact 10/12/59. He has not previously been interviewed in respect to the matters concerned in U. S. vs BONANNO or re the Apalachin meeting hoodlums. No information has yet been obtained from [REDACTED]

Mrs. ANNA DILLENBECK

Two letterhead memoranda forwarded covering interviews at Endicott, N.Y., on 2/11/58 and 3/12/58.

In respect to the interview of DILLENBECK on 2/11/58 this was set out initially in report of SA PATRICK A. MUNLEY dated 4/30/58 at Albany, captioned "JOSEPH BARBARA, SR., Was., Anti-Racketeering," which is not suitable for dissemination. It should be noted that the report indicates that the investigation was conducted by SA DARWIN D. SHATRAW; however, in checking SA PATRICK A. MUNLEY was present during the interview which was jointly conducted by these two Agents. The memo reflects these Agents conducted the interview and it is requested that Bureau copies of the report be altered to make this correction (at page 26). Albany reports have been corrected.

The interview on 3/12/58 was initially set out in Albany letter to Philadelphia 3/24/58 (interoffice).
