DAVIDSON says he'll be having seder with his mother while in Pittsburgh, then inquires what the special oc-casion for the seder at the Hilton Hotel. YARIV Peplies that SOL BRAUMAN (ph) and DAVE LOWENTHAL (ph) are holding a seder there and some of "our" people are going there for it. DAVIDSON says he understands: a fund-raising deal.
