On December 6, 1960, a confidential informant, who has furnished reliable information in the past, advised that Avraham Salmon of the Embassy of Israel Shad been in contact with I Irving Davidson, a Washington, D.C., businessman and registered as an agent for the Government of Israel

The "Diplomatic List" Spublished by the Department of State, for October 191960, lists Avraham Salmon as Economic Counselor at the Embassy of Israel, Washington, D.C.

According to the informant, Davidson and Salmon had discussed a matter previously which indicated there was a third party who was unknown to the informant and for whom Davidson was attempting to negotiate a sale of gold. Salmon however, reported that Mr. Sidney Green, associated with the Streasury of Israel in New York, New York, is the only person suthorized by the Treasury of Israel to deal in such matters.

Davidson has indicated that his only mission is to determine the amount Green as willing to offer for the gold.
