MEJIA SAID SUBJECT AT TIME IDENTIFIED THE CAR AS HIS PROPERTY BUT LATER TOLD ANOTHER STORY IN A FORMAL DECLARATION. *LCU*

MEJIA STATED PLYMOUTH HAD MEXICO TOURIST STICKER SHOWING CAR ENTERED MEXICO AT REYNOSA, TAMAULIPAS, IN MAY, NINETEEN SEVENTYONE, UNDER FOLIO NUMBER ONE TWO TWO SEVEN FIVE EIGHT, IN THE NAME OF MELVIN BLEETSTIEN. MEJIA REMOVED FROM INSIDE THE CAR (A) A MEXICAN TOURIST CAR ISSUED TO MELVIN BLEETSTEIN; (B) A MEXICAN TEMPORARY IMPORTATION PERMIT FOR THE CAR ISSUED TO BLEETSTIEN ON MAY NINETEEN, NINETEEN SEVENTY-ONE; (C) A DOCUMENT WHICH APPEARED TO BE A VIRGINIA TITLE FOR THIS CAR, NUMBER FOUR THREE FIVE FIVE DATED APRIL FIVE, NINETEEN SEVENTYONE; AND (D) A NUMBER OF BLANK BIRTH CERTIFICATE FORMS. *LCU*

IT IS NOTED THAT COPIES OF THESE DOCUMENTS, EXCEPT FOR (C) WERE FURNISHED TO BUREAU AND MIAMI BY MEXICO CITY AIRTEL SEPTEMBER TWELVE, NINETEEN SEVENTYTWO. *LCU*

ON MAY SEVENTEEN INSTANT, CARLOS ACEVES FERNANDEZ, CHIEF, SECRET SERVICE, GUADALAJARA POLICE DEPARTMENT, ADVISED THAT MEJIA DOES HAVE AUTHORIZATION TO TRAVEL TO THE UNITED STATES AND TESTIFY IN CAPTIONED MATTER. U.S. CONSULATE AT GUADALAJARA ARRANGING FOR AIRPLANE TICKETS. *(u)*

DETAILS CONCERNING FLIGHT PLANS OF MEJIA WILL BE FURNISHED PROMPTLY WHEN AVAILABLE. INTERVIEW REPORT FORM BEING FORWARDED TO BUREAU BY POUCH, MAY SEVENTEEN INSTANT. *(u)*
