Enclosed for Miami and Washington Field Offices is one copy each of Central Intelligence Agency intelligence information cable ZDC302-215/02230-65 entitled "Efforts of Guillermo Belt Ramirez to Recruit Gullon for Duty in the Dominican Republic."

Also enclosed for assistance of Washington Field is copy of Miami airtel and letterhead memorandum 6-11-65 concerning captioned matter.

Duffles disclose that Guillermo Belt Ramirez is apparently the father of [redacted] currently a PSI of Washington Field; Washington field file 101-3000.

In view of Washington Field's relationship with the FBI and since the most current information in Duffles indicates Guillermo Belt Ramirez is residing in the Washington, D. C., area, Washington Field should, unless reason to the contrary not known to the Bureau exists, [Interview FBI regarding his father's alleged approach to Constanzo Palau.]

Upon completion of interview, Washington Field should also submit its recommendations concerning necessity of investigation into the activities of Guillermo Belt Ramirez.

NOTE: [June 9, 1965, CIA furnished data indicating subjects were forming a commando force in Miami to be used by Dominican General Antonio Imbert. They were reportedly recruiting Cuban refugees and American adventurers to make up this force. ~~We~~ We are conducting investigation in this regard. It appears that possibly the approach made by Belt Ramirez may have been in connection with the same allegation and since his son is a PSI, he may be in a position to furnish worthwhile information thereby saving investigative time and effort. X
