Re New Orleans airtel 4/6/67. *VINCENT MARCELLO*

NO 1457-C-TE advised on 4/10/67 that MARIO MARINO and his spouse GLADYS were entertained at the home of CARLOS MARCELLO's mother during the evening of 4/7/67. Present at this dinner party were VINCENT and SADIE MARCELLO (CARLOS MARCELLO's brother), and JOSEPH MARCELLO, JR., and his wife (CARLOS MARCELLO's son), together with several other people. CARLOS MARCELLO at his mother's house during early evening for a brief period. No business discussed. Upon his departure, CARLOS MARCELLO remarked that he was taking several political figures to dinner and that it was about the "domed stadium deal".

It has been previously reported to the Bureau that CARLOS MARCELLO has interested himself in the erection of the new domed stadium in New Orleans. MARCELLO attempting to get the site of this domed stadium on his property.

Informant advised that MARINO and wife spent day of 4/8/67 visiting family relatives in Kenner, La. MARINO advised informant he was staying over in New Orleans several extra days in an attempt to change CARLOS MARCELLO's position.
