ADMINISTRATIVE: (continued)

As a disruptive tactic, surveillance was conducted on MARCELLO on 4/5/67 when he was meeting MARIO MARINO of Las Vegas, Nevada. It is noted this surveillance greatly upset MARCELLO. NO 1457-C-TE advised that MARCELLO has been very upset by this surveillance and by frequent spot checks conducted at his home by Buagents. Informant further advised that the program of interviewing close friends of MARCELLO is very perturbing to him.

The records of numerous toll calls made from fourteen telephones available to CARLOS MARCELLO were checked and the results of this investigation incorporated in the case captioned, "LaStella Restaurant Meeting, November 22, 1966; AR." This data not being set forth again in this report to avoid repetition.

NY 5593-C-TE advised on 4/10/67 that JOSEPH COLUMBO has indicated to the informant that he is in negotiation relative to an automatic shoe-shine machine business which would cost \$250,000 for 25% of this business. One of the names he mentioned was CARLOS MARCELLO.
