MARCELLO stated his lawyer JACK WASSERMAN has the photo. Former WF 1633-C-TE stated he contacted WASSERMAN and was exhibited the photo which confirms MARCELLO's claim above. In addition WASSERMAN claimed he found a serious error in the impaneling of the FGJ which indicted MARCELLO in this matter. The former source stated it was obvious to him that such evidence seemed very flimsy as a defense inasmuch as MARCELLO could easily have switched his coat to the other arm; or the photographic print could have been contrived by reversing the negative.

WFO is not aware of the facts in the attempted assault case against MARCELLO; however, it is possible that MARCELLO and WASSERMAN are claiming the above in the hope that it might cause the Government to reconsider its case against MARCELLO.

UACB, WFO will not ask former WF 1633-C-TE to obtain above-mentioned photo from WASSERMAN.
