Among these associates would be Santo Trafficante, La Cosa Nostra leader in Florida. The New Orleans Office advised that they have \$100 authorization for payment to this informant still outstanding and requested authorization for an additional \$2003 in order to provide the informant with sufficient funds to make this travel. With the informant in the company of marcello, it is extremely likely that significant information can be obtained concerning Marcello's current activities with his hoodlum associates in Miami. In view of the emergency nature of this request, and the benefits to be gained from this payment, New Orleans was authorized to expend an additional \$200.
