Enclosed herewith are the original and seven copies of an LHM dated and captioned as above.

NY T-1, mentioned in the LHM, is MR. JOHN ROCHFORD, Manager, Chemical Bank New York Trust Company, Grove and West Fourth Streets, NYC.

The Bureau is requested to contact the RCMP to determine, if possible, whether the subject rented a car through Avis Transport of Canada, Ltd., and also to secure all information he supplied Avis in his application for car rental. (S)

Avis Rent-a-Car System in New York has advised that this information is not available through them and that Avis Transport of Canada, Ltd., Montreal, would have to be contacted to secure this information. (S)

It is to be noted that although a record at INS, NY, indicated that the subject left the U.S. for Milan, Italy, on 5/4/64, no record could be found indicating that he returned to the U.S. through New York. The information in the enclosed LHM gives rise to the possibility that he may have returned to the U.S. through Canada.

New York is not in receipt of any information that the subject has made any trips recently not in his personal car.
