The Bureau is requested to contact the RCMP to determine, if possible, whether the subject rented a car through Avis Transport of Canada, Ltd., and also to secure all information he supplied Avis in his application for car rental.

Avis Rent-a-Car System in New York has advised that this information is not available through them and that Avis Transport of Canada, Ltd., Montreal, would have to be contacted to secure this information.

It is to be noted that although a record at INS, NY, indicated that the subject left the U.S. for Milan, Italy, on 5/4/64, no record could be found indicating that he returned to the U.S. through New York. The information in the enclosed LHM gives rise to the possibility that he may have returned to the U.S. through Canada.
