Dear Mr. Innes:

This is further to our letter of August 14, 1964 and your letter of July 31, 1964.

2. A source believed reliable advised that Richard C. FRANK, 110 Christopher Street, New York 14, N.Y., rented an automobile from the Avis Car Rental Service, Toronto International Airport, Malton, Ontario, on May 19, 1964 at 9:30 a.m. This vehicle was returned to Avis in Buffalo, New York at 1:34 p.m. of the same date. When the vehicle was returned it had travelled 126 miles.

3. FRANK produced as reference, his Sheraton Card No. 27888426 and was in possession of New York State Drivers License No. 18050-42476-89548.

4. Attached please find photographs of the Avis Rental Agreement which was signed by FRANK.
