MRS RICHARD CYRIL FRANK

T-1, a confidential source abroad, has informed that RICHARD FRANK, born August 22, 1922, American citizen, television worker, married to MILDRED SUSAN FRANK, born November 8, 1913, residing at Christopher 110 (sic). New York, resided at the Hotel Victoria, Geneva, Switzerland, arriving alone from New York, from May 5 to 13, 1964, and at the Hotel du Jet d'Eau, Geneva, arriving from New York, from May 13 to 14, 1964. No pertinent information was obtained at the first hotel concerning the reason for his stay in Geneva. At the second hotel, where he just stayed for a night, it was recalled that FRANK had been in possession of a great amount of photographic material and that he had not stayed with anyone.

It should be noted that Swiss television was not called on to collaborate with FRANK, which is customary for professional reasons when a representative of a foreign television organization comes to Switzerland, and is usually done through Eurovision, whose Swiss office is at Zurich.
